	Circles UK is a small national charity established to quality control the delivery of "circles" by the local providers. Circles are a method of supporting sex offenders following their release from prison to not reoffend. Our funding will pump prime the creation circles in North Wales, which will then be funded by local agencies in the future.					
	The grant is also allowing Circles UK to pilot a new "circle" model to support low risk sex offenders. It is anticipated the new low risk circle will give local circle providers more opportunity to support their communities and secure additional statutory funding.

Circles UK worked with the Ministry of Justice (MOJ) / HMPPS on creating a co-commissioning framework for the joint funding of Circles from police, PCCs, Probation and Prisons. This document was issued jointly from MOJ and Circles UK in March 2019 and is currently under discussion by Probation, Police, PCCs and Prison Governors. The re-unification process (when staff move from private providers back to the National Probation Service) is expected to happen at the end of June 2021. Services will then be commissioned regionally through co- commissioning arrangements between probation, police, PCCs and other key stakeholders. Funding may be made available for Circles provision through this mechanism.

At the time of writing the end of grant report, the agreement with Licoln University and Online Protect has been finalised and is in place.

			Online Protect and Circles Providers. The launch of the new programme (called Circles ReBoot) took place in September 2020 through an online event. It was a highly successful event which was attended by close to a hundred people. Key speakers at the launch included Chief Constable Simon Bailed who reiterated the support of the police for the programme, the advisor to the programme (Prof Derek Perkins), the Lincoln University /Online Protect evaluation team, Circles UK staff and Trustees, Circles Providers and other key stakeholders from both national and international organisations. The launch event explained the programme methodology, who it is intended for and how the programme would be piloted and evaluated. The launch event received excellent feedback. Circles UK also published a blog in a number of publications after the event to promote the new programme.

As it is a face to face programme which will be piloted and evaluated before final roll out, the implementation could not be shifted to online delivery. It is intended to include 12 Circles ReBoot in the pilot. The first pilot Circle is due to start in May 2021. The full pilot is expected to complete by November 2021 (as Circles ReBoot is a 12 session programme, delivered over 6 months).

4. Optional – please detail any additional expected achievements you would like us to know about.

It has been decided to focus the Circles programme for low risk people on people who access illegal images of children and commit non-physical contact offences as there is such a demand for services to address this issue. The partnership with Lincoln University and Online Protect is an extremely positive development and will give research and theoretical validation to the programme design. Due to this partnership, it was decided to pilot and evaluate the programme before full implementation as that would enable a full testing of the effectiveness of the methodology. This is important as this is the first Circles programme of its kind that has been developed internationally and there is significant interest in the programme. Although doing a pilot and a full evaluation have caused delays to the final implementation, we believe that the pilot and evaluation approach will increase the credibility of the programme. This is important as there has been a significant increase in the number of people who access Child Sexual Exploitation Material during the COVID-19 lock down period. Interventions to address this form of abuse are urgently needed, but it is crucial to develop credible and evidence based programmes which is what the pilot and evaluation of Circles ReBoot will hopefully show.

Please explain how these figures relate to the budget submitted for the grant and any assumptions made.

The application to the Triangle Trust is for a total of £70,000, £35,000 in year one (2018/19) and £35,000 in year 2 (2019/20). In year 1 (2018/19), CUK still needs to raise £25,000 to deliver its total projected budget (at the moment £330,000 of £355,000 is secured). Similarly in year 2 (2019/20), CUK needs to raise £145,000 that is not yet secured. In year 3 we need to raise £80,000. We have targeted other funders apart from the Triangle Trust and I can provide more information as required. Circles UK also holds an amount of £102,000 in Reserves which is over and above the projected budgets for the 3 year period.

6. Has any aspect of the grant delivery not progressed as expected and have any subsequent changes been made?

Yes, there has been a delay to outcome 3 (development of the low risk Circles programme) due to the decision to pilot and evaluate the new programme as well as the impact of

COVID lock down restrictions as outlined in section 3 above. However, the piloting of the programme and the full evaluation will improve the final product and is an advantage. This delay is therefore not a set back, but COVID-19 has resulted in an additional delay of 6 months which is a set back.

7. Has the grant achieved the expected results overall or did anything need to change?

It is envisaged that the results of the grant will be achieved, although there will roughly be a 6 month delay to the roll out of the low risk Circles programme due to the reasons outlined above as well as the impact of the Corona virus Covid19 lock down restrictions.

8. What are the future plans for the development funded by this grant? (include details of any further funds secured to continue the work)

This is the end of grant report. However, I was hoping that Circles UK could apply for another grant from the Triangle Trust. We have been extremely grateful for the support of the last 3 years. It seems from the Triangle Trust website that funding is now only available for young offenders and not for adults. Clarity will be sought on this aspect.

9. Is there anything you have not included elsewhere in the report that you feel we should know? E.g. you might have some wider reflections about the impact of the grant overall both within your organisation and beyond.

The COVID-19 virus brought unprecedented challenges. This has presented additional risks for Circles UK and Circles Providers as we needed to design alternative ways of providing Circles at very short notice. Many of our service users are high risk individuals for whom social isolation may present additional risky situations. The majority of sexual abuse takes place in homes and the lock down may intensify the risks to children who are potentially in one space with their abuser.

The grant from the Triangle Trust enabled us to develop Circles Reboot for those who access Child Sexual Exploitation Material. It turned out that this work could not have more timely as there has been a significant increase in this type of offending during the COVID-19 lock down period. A number of organisations reported significant increases in online abuse. The Internet Watch Foundation (IWF) reported an increase of almost 50%. From March to July 2020, its hotline logged 44,809 reports of images compared with 29,698 the year before. At least 8.8 million attempts by UK internet users to access videos and images of children suffering sexual abuse were blocked during lockdown (IWF website). The National Crime Agency estimates that at least 300,000 UK citizens pose a risk of online sexual harm to children (April 2020 statement). In April 2021 the police reported that an average of 700 children are being safeguarded every month in relation to online Child Sexual Exploitation. Circles UK is extremely grateful to the Triangle Trust for enabling us to develop this highly relevant and crucial new programme.

COVID-19 continued to pose significant challenges throughout 2020/21 and Circles UK had to continue to provide additional support to Circles Providers. Many of the Core Members (service users) that we work with in Circles are not allowed to access the internet due to the crimes that they have committed. Telephone contact therefore became extremely important and Circles UK provided guidelines to Providers on how to make telephone calls with service users more meaningful. We also designed online training for Circles Coordinators to ensure that they had continuous training and development support. In February 2021 we facilitated an online event for Coordinators which focused on resilience. The feedback from this event was extremely positive. We are also hosting a series of additional online seminars for Circles Coordinators – in March 2021 we got a guest facilitator to present a seminar on a new risk management tool that is used for sex offenders.
