



Grant Summary

The grant would provide wages for a development worker to oversee and develop LifeHab, our new, 45-bed supported housing.

Anticipated expenditure is Year 1 = One full-time coordinator, £25,000 plus NI £2287 plus pension £321.12 = £27,608.12.

Year 2 = £25,000 Year 3 = £20,000

This amount would be reduced over 3 years as we have more funds coming in to sustain us. We would like this funding to continue over 3 years, to enable us to sustain and safely grow the project.

Grant Performance

Whilst being marked as amber this grant has undoubtedly provided On the Out with the opportunity to try out some things that they would not have been able to do. It has also enabled them to assess how things are going and move away from relationships and opportunities that weren't working.

At assessment it was noted that this was an organisation with potential but one that was at the very early stages of development. The support of this grant has helped to move them on from this place to being recognised as a key delivery partner in Greater Manchester. One of the great strengths of On the Out was that it was led by people with significant personal experience of the criminal justice system and these experiences had defined their aims and approach. Despite the changes to the business plan and model they have retained the core ethos of the organisation being led by those who have lived experience and have provided increased opportunities for employment to this group.

Despite not fitting into the main Spark Programme cohort, the CEO has benefited from Cranfield Trust mentoring and a consultancy project was mapped out but due to the fast moving nature of the organisation's trajectory this was paused and not restarted. So whilst this has been a bit of a bumpy road for On the Out the grant has benefited them hugely in helping them to establish themselves and find the right way forward.

Improved ability to measure progress and change for Lifehab participants.

We have developed new systems which are able to measure outcomes for the people we work with, alongside a way to measure people's perceptions of their own change. We are building a bank of case studies which illustrate our work, alongside more detailed feedback from the people we work with.

Diversity of income

Despite not continuing with supported housing, we have managed to diversify our income away from grant funding and towards contracts. We are delivering these contracts well (CAS 3, RSI) and are now the support provider for Manchester and Bolton CAS. Here our workers have excelled. They have been commended on a national level and worked alongside probation as colleagues. CAS 3 has enabled an increase of 9.5 full time support worker posts, all ex - prisoners. For most, it is their first legitimate job. We expect CAS 3 to continue to expand. Following the success of the vanguard areas, it has now been rolled out nationally. This will help to sustain On the Out. Notable are the relationships forged between On the Out workers and probation – with new ways of working as colleagues and equals.

Developing Lifehab Manchester

We have been on quite a roller coaster regarding the development of Lifehab, not all of it positive. We made the decision that our proposed housing in Manchester – in a building purchased by the Edward Holt Trust - would be unsustainable. Aside from difficulties with the council and the building (which required considerable input), rises in the cost of living meant that we would have been running at a considerable deficit. We made the decision to discontinue and refocus the framework of our Lifehab programme within our group programme.

Our group programme has grown steadily during the last year. We now run well attended groups 3 x weekly. These groups focus on wellbeing and behavioural change, utilising a model of peer support, with our facilitators guiding work. We also run workshops within Risley prison, encompassing this model. Feedback from the sessions suggests the strong impact made. We aim to continue these groups and extend into our work within the Approved Premises.

Yes, we had to shift away from the idea of supported housing towards a group programme, transferring our central ideas around behavioural change, peer support, identity change and rehabilitation.

We are seeking funding from the probation service to help us fund this work. We also have some funding for our groups through Our Manchester.
